

# Corporate Fact Sheet

- What We Do** Orenco Systems designs and manufactures leading-edge products for the decentralized collection, treatment, and monitoring of wastewater. Our products help ensure the health and safety of people, neighborhoods, and communities everywhere by protecting the world's water.
- Products and Services** The company has three product divisions: Orenco Water™, Orenco Composites™, and Orenco Controls™. Products include Prelos Sewers™ (liquid-only sewer systems, also known as effluent sewers); secondary treatment systems (including AdvanTex® textile filters in a range of sizes for residential, commercial, municipal, and mobile applications); watertight tanks, basins, scrubbers, and wet wells; pumping and filtration systems; standard and custom electronic control equipment; and fiberglass buildings and various other fiberglass products. We provide technical sales support for all our customers, ongoing support for system operators, and design guidance for large systems.
- Markets** Individual homes and businesses use Orenco's fiberglass tanks, pumping systems, secondary wastewater treatment systems, and electrical controls. Growing communities that need to install, replace, or expand wastewater collection and treatment networks use Prelos Sewers and AdvanTex Treatment Systems. Oil, gas, and mining operations use Orenco's mobile wastewater plants. In addition to electronic controls and telemetry for wastewater systems, Orenco also manufactures custom and OEM electronic controls and industrial fiberglass products for a variety of industries.
- Facilities** The company has 477,000 total sq ft (44,315 sq m) of facilities under roof in the following locations:
- Sutherlin, Oregon: 150,000 sq ft (13,935 sq m) of facilities on a 26-acre (10.5-ha) site
  - Winchester, Oregon: 137,000 sq ft (12,728 sq m) of facilities on a 45-acre (18.2-ha) site
  - Wilbur, Oregon: 190,000 sq ft (17,652 sq m) of facilities on a 4.5-acre (1.8-ha) site
- Distribution** We sell our wastewater products through about 330 points of distribution in North and Central America, Australasia, Europe, and Africa. Custom controls are sold through many of these same distribution points, as well as through direct OEM relationships.
- Ownership** Orenco is a privately owned company governed by a Board of Directors, whose chairman is Terry Bounds, P.E.
- History** Orenco Systems was established in Oregon, USA, in 1981. The company pioneered the local use of effluent sewers and sand filters for decentralized wastewater collection and treatment. In 2000, Orenco introduced its flagship product, the AdvanTex textile filter, followed in 2001 by the VeriComm® Remote Telemetry Control Panel and Monitoring System – a scaled-down SCADA system priced for the residential onsite wastewater market. In 2014, Orenco began to apply its expertise in composites to the manufacturing of large-scale industrial products. The Prelos Processor™, the core of a Prelos Sewer, was introduced in 2019.
- Orenco's technologies are based on sound scientific principles of chemistry, biology, mechanical structure, and hydraulics. As a result, our research appears in a variety of publications, the company has held numerous patents, and our engineers are regularly asked to give workshops and trainings. We maintain an environmental lab and employ dozens of civil, electrical, mechanical, and manufacturing engineers, as well as wastewater treatment system operators.
